



## TERMS AND CONDITIONS

### Eligibility

**To be eligible for Brisbane City Council's Pool Cover Rebate, you MUST comply with the following:**

- All rebates apply solely to domestic pool covers, and do not cover renting, leasing, hiring arrangements or commercial applications.
- The pool cover can be purchased with or without a pool cover roller. The only roller eligible for a rebate is a roller purchased with a pool cover. There is no rebate available for rollers purchased separately without a pool cover.
- Eligibility is confined to owners of residential dwellings within the boundaries of Brisbane City Council. The dwelling must be connected to the Brisbane City Council water supply. The program is limited to a maximum of one rebate per dwelling.
- Residential bodies corporate are eligible. Bodies corporate of commercial and non-residential properties are not eligible.
- Pool covers must be purchased, paid for in full and fully installed before a rebate can be applied for.
- To be eligible for a pool cover rebate, the property owner/body corporate must fill in and sign the rebate application and include a copy of the tax invoice. The tax invoice must show:
  - pool cover make and model number
  - pool cover dimensions
  - address where the pool cover will be installed
  - amount paid in full
  - pool cover has a five year warranty.
- The pool cover must be properly installed at the address specified on the tax invoice and application.

### The Rebate Amount

- A pool cover rebate of up to \$200 is available. The rebate amount cannot exceed the total purchase price.

### Qualifying Pool Covers

- Pool covers must have a minimum 25 square metre surface area.
- The rebate is only available for pool covers that have a minimum thickness of 400 microns; have a minimum five year warranty and are designed to prevent water evaporation.
- For rebate applications received after 1 January 2007, pool covers will require approval under the Smart Approved WaterMark Scheme.
- This program only applies to new pool covers and does not apply to used or second hand pool covers.
- Pool covers purchased from the Brisbane Water 'Watersense Blue Van' are not eligible for the program.

### Program Period

- This Program will operate from 20 May 2006 – 30 June 2007.
- Brisbane City Council reserves the right, at its sole discretion and at any time, to change any or all of the Terms and Conditions for the program or to cancel the Program prior to 30 June 2007. Applications must be received by Brisbane City Council within 90 days of the published program termination date.

### Accompanying Information

- Applications will take approximately four weeks to process. If the application is successful, applicants will receive a notice in the mail with a cheque attached. Unsuccessful applicants will be notified by mail.
- Documents attached to your application will not be returned.
- Information provided may be used for audit purposes. This is to ensure that the product purchased has been correctly installed and is within the Terms and Conditions of the program.
